The California New Motor Vehicle Board (CA NMVB) will host its 2022 Industry Roundtable, including workshops on Equity, Justice, and Inclusion in the Motor Vehicle Industry, on September 28 and 29, 2022, at 10 a.m.–12 p.m. The workshops will be held virtually, via Zoom and teleconference calls. Topics of discussion will include the following:

- The state of the industry with respect to diversity in the automotive franchise network.
—Speakers will be from the National Association of Minority Automobile Dealers and Sheridan Honda and Sheridan Powersports in Wyoming.
- Equity and diversity in the motor vehicle industry.
—Discussion participants will include representatives from Ford, General Motors, Nissan, Stellantis, and Toyota.
- Equity and electric/alternative fuel vehicles.
—Speakers will be from the California Air Resources Board, EV Equity Program, Central California Asthma Collaborative, and National Association of Minority Automobile Dealers.

Background

On an annual basis, CA NMVB hosts an Industry Roundtable with representatives from car, truck, motorcycle, and recreational vehicle manufacturers/distributors, dealers, in-house and outside counsel, trade associations, community-based organizations, and other governmental entities. This year's Industry Roundtable focus is equity in the new motor vehicle industry and public policy surrounding zero-emission vehicles and infrastructure.
