New Information

The Special Interest License Plate (REG 17) form was revised and renamed the Special Interest or Environmental License Plate (ELP) Application (REG 17, REV 2/2025). The Special Recognition License Plate Application (REG 17 A, REV 2/2025) was also revised. Both revised forms include the addition of a privacy statement, vertical lines in the *LICENSE PLATE* and *VEHICLE IDENTIFICATION NUMBER (VIN)* fields, and page number bar codes on each page.

These forms are available on the Department of Motor Vehicles (DMV) website. Printed inventory will **no** longer be available. Begin using the 2025 revision immediately.

NOTE: The older revision of these two forms can be accepted until July 1, 2025.

Special Interest or Environmental License Plate (ELP) Application (REG 17, REV 2/2025) Page 1

- Top of form
 - The new REG 17 is primarily used for REPLACEMENT, REASSIGNED, RETAIN, RELEASE, OR EXCHANGE transactions. For original applications customers are encouraged to use the Special Interest and Personalized License Plate Order online.
 - The note regarding the same configuration cannot be reissued for REPLACEMENT SPECIAL PLATES has been moved to Section 3.
 - The following was revised: NOTE: The department will not honor a change of license plate selection or letter/number configuration, or a request for refund after this application is submitted.

 - List of plates was reconfigured into three columns.
- SECTION 2 SELECT CONFIGURATION
 - All references to stating the meaning of a proposed license plate were deleted, including the line intended for an explanation.
- SECTION 3 FOR REPLACEMENT ONLY
- California Vehicle Code reference was added to the Graybar section.
- • SECTION 4 — REASSIGN, RETAIN INTEREST, OR RELEASE INTEREST
 - REASSIGNED check box was added with fields for license plates and VINs.
- SECTION 5 PLATE PURCHASER
 - PLATE PURCHASER was changed to PURCHASER.
 - *PLATE OWNER* was changed to *HOLDER*.
- SECTION 6 SIGNATURE
- DAYTIME PHONE NUMBER was changed to TELEPHONE NUMBER OR EMAIL ADDRESS.

Special Recognition License Plate Application, (REG 17 A, REV 2/2025)

This revision of the REG 17 A reflects the following changes:

- Honorary Consul was deleted.
- Ex-Prisoner of War (POW) was changed to Former American Prisoner of War (POW).

- SECTION 2 PLATE SELECTION
 - Information about regarding Motorcycle license plates was expanded. Note: For Gold Star Family and California Firefighter Motorcycle license plates, decals are applied to a white license plate.
 - List of plates was expanded to three columns.
 - California Firefighter area was reformatted, and the meaning explanation line was removed.
 - License Plates were split into three columns/boxes:
 - o Certification Required Applicant must complete section 2A or 2B.
 - Documentation AND Certification Required Applicant must complete section 2B or 2C.
 - Documentation AND Declaration Not for Hire Applicant must complete new Section 3.
- SECTION A. PRESS PHOTOGRAPHER CERTIFICATION (previously Section 2C)
 - Applicant is now required to certify and a section under the Employer area was added.
 - *TELEPHONE NUMBER OR EMAIL ADDRESS* field was added to both Employer and Applicant signature lines.

- SECTION B. HISTORICAL VEHICLE AND HORSELESS CARRIAGE CERTIFICATION (previously Section 2E)
 - TELEPHONE NUMBER OR EMAIL ADDRESS field was added.
- SECTION C. CALIFORNIA FIREFIGHTER (Surviving Family Member) CERTIFICATION (previously Section 2F)
 - TO DECEASED was added to the RELATIONSHIP field.
 - TELEPHONE NUMBER OR EMAIL ADDRESS field was added.
- SECTION 3 DECLARATION NOT FOR HIRE
 - Entire language for this section is as follows: I declare that the vehicle to which a Pearl Harbor Survivor, Congressional Medal of Honor Recipient, Purple Heart Recipient, Former American Prisoner of War (POW), or Legion of Valor license plate is assigned shall not be used for transportation for hire, compensation, or profit (*California Vehicle Code* [CVC] §§5101.4, 5101.8 and 9105).

 - Check boxes were added for Retain Interest for Future Use, Release Interest/Surrender to DMV, and Reassign.
 - Fields for *PLACED* (*CURRENT LICENSE PLATE NUMBER*) and *PLACED ON* (*VIN*) were added.
- SECTION 5 REPLACEMENT (previously Section 4)
 - SPECIAL RECOGNITION LICENSE PLATE NUMBER field was added.
- SECTION 6 SIGNATURE OF LICENSE PLATE HOLDER OR PURCHASER
- TELEPHONE NUMBER OR EMAIL ADDRESS field added.
- Mailing address and online application website was added.
- List of license plate table with *California Vehicle Code* (CVC) sections and the requirements for these plates were updated.
- Privacy Statement was added.

NOTE: The process for the replacement of stolen Special Recognition License Plate(s) has **not** changed. See *Vehicle Industry Registration Procedures Manual*, Duplicates and Substitutes, Chapter 20.075

Background

Starting in 2017, the Policy Division began updating the Title 13 regulations governing the content of the Reg 17 and REG 17 A forms. In November 2024, the Office of Administrative Law approved the proposed regulations. The forms have been updated and modernized to meet current standards regarding the collection of private information, without modifying the content that would affect the approved regulations.

SPECIAL RECOGNITION LICENSE PLATE REQUIREMENTS

Amateur Radio Station	Issued to the motor vehicle for which registration is sought by any person holding an unexpired amateur radio station license issued by the Federal Communications Commission. A copy of the license must accompany the application. The license plate's configuration will be the official amateur radio station call letters. Licensee may obtain only one set of license plates (<i>California Vehicle Code</i> (CVC) §5005).
Antique Motorcycle	Issued to any owner of a motorcycle manufactured in 1942 or prior. A copy of the vehicle registration must accompany the application. For a 1943 model year motorcycle manufactured in 1942, a copy of the manufacturer's Certificate of Origin or a letter from the manufacturer indicating the manufacture date of the motorcycle must be provided (CVC §5004.5).
California Firefighter and California Firefighter	Issued to a vehicle owned, co-owned, or leased by a firefighter, retired firefighter, or volunteer firefighter, or to a surviving family member (spouse, domestic partner, or any child, including an adopted child, stepchild, or recognized natural child) of a deceased firefighter, retired firefighter, or volunteer firefighter. Surviving family member does not include a former spouse. Documentation must be submitted with the application (CVC §5101.2).
(Surviving Family Member)	Acceptable documentation is: Firefighter Department Identification (ID); International Association of Firefighters (IAFF) Membership Card; or California Professional Firefighters (CPF) Callback Association Membership Card.
Congressional Medal of Honor Recipient	Issued to a vehicle owned or co-owned by a Congressional Medal of Honor recipient. A copy of the owner's service record, a copy of the Department of Defense form 214, or a copy of the official Congressional letter which was given to the recipient when the award was bestowed must accompany the application (CVC §5101.6).
Former American Prisoner of War (POW)	Issued to a vehicle owned or co-owned by a former American prisoner of war as defined in CVC §324.5. Documentation submitted must be one of the following: A letter of verification from the National Personnel Records Center or discharge papers declaring the bearer to be a former American POW (CVC §5101.5).
Gold Star Family	Issued to a vehicle owned, co-owned, or leased by an eligible family member as defined in CVC §5156(d) (2)(C). The Report of Casualty (DD1300) form from the Department of Defense and the Project Gold Star License Plate Application (VSD 5 1918) from the California Department of Veterans Affairs must accompany the application.
Historical Vehicle	Issued for a vehicle manufactured after 1922, which is at least 25 years old, and is of historic interest. Vehicle is primarily operated or moved over the highway in historical exhibitions, parades, or historic vehicle club activities. For commercial vehicles only: The Certificate of Ownership must be submitted with the application (CVC §5004).
Horseless Carriage	Issued to a motor vehicle manufactured in 1922 or prior, or with an engine of 16 or more cylinders manufactured prior to 1965. Motor vehicle is primarily operated or moved over the highway in historical exhibitions, parades, or historic vehicle club activities (CVC §§5004 and 5004.1).
Legion of Valor	Issued to a vehicle owned or co-owned by an Army, Navy, or Air Force Medal of Honor recipient, or an Army Distinguished Service Cross, Navy Cross, or Air Force Cross recipient. A copy of the owner's service record or Department of Defense Form 214 must accompany the application (CVC §5101.4).
Press Photographer	Issued to a person regularly employed or engaged as a bona fide newspaper, news magazine, news gathering, newsreel, or television photographer or camera person. The vehicle owner may obtain only one set of these license plates (CVC §5008).
Purple Heart Recipient	Issued to a vehicle owned or co-owned by a Purple Heart recipient. Copy of Executive Order awarding the Purple Heart, owner's service record, or Department of Defense form 214 reflecting the owner's Purple Heart Award is required with the application (CVC §5101.8).

Note: Holder includes co-holders and lessees (CVC §460)
