New Information

The Lien Satisfied/Legal Owner /Title Holder Release (REG 166, REV. 12/2016) and Application for Duplicate or Transfer of Title (REG 227, REV. 8/2017) forms have been revised.

Changes to the REG 166

• The statement "This form cannot be used for a vehicle with a paperless title" was added.

Changes to the REG 227

- The form was renamed Application for Duplicate or Transfer of Title.
- The statement "This form cannot be used to release a lien on a vehicle with an Electronic Lien Title (ELT)" was added.
- The Paperless Title Certification and Transfer of Title with Duplicate or Paperless Title options were removed.
- The Transfer of Title with Duplicate option was added.
- In Section 2, the Electronic Lienholder ID Number field was removed.
- In Section 3, the Paperless Title option was removed.
- In Section 5, the statement "This section and the Lien Satisfied (REG 166) cannot be used for non-ELT participants with vehicles 2 model years old or newer. The legal owner (i.e., bank, finance company, etc.) of record must apply for a duplicate title first, and then release interest on the actual title" was added.

Background

The Department of Motor Vehicles (DMV) ELT Program allows a lienholder's title information to be held in electronic format in DMV records. When the lien is satisfied, the lienholder electronically notifies DMV to release a title. After a review of ELT records, it was discovered that some lienholders were removed without their knowledge when a REG 166 and REG 227 were used together to fraudulently release the lienholder's interest.

The *Vehicle Industry Registration Procedures Manual* will be updated to reflect the new information.

This form cannot be used for a vehicle with paperless title or a vehicle that is two model years or newer. The legal owner interest for a vehicle two model years or newer can only be released using a Certificate of Title.
